








## What are the Net Zero Guidelines?


- A core reference text for credible net zero action
- Draws on the existing landscape of major net zero standards and initiatives
- Can be used by any organization, but are particularly targeted at 'rule setters' for net zero guidance
- Aimed to support national, regional, city and individual organizations to accelerate their net zero action

## Addressing greenwashing and net zero integrity



The UN has called for greater action on the problem of 'greenwashing' in climate action.



In the absence of a clear framework of standards and regulation for net zero, misleading and inaccurate claims have become widespread.



The Net Zero Guidelines is not just about bringing clarity to net zero action, but also helping to bring clarity to what it is not.



The UN published its *Integrity Matters* report at COP27 which set out recommendations for what must be done to restore integrity to net zero and called for the establishment of a taskforce on net zero regulation.

## **Agile**

The Net Zero Guidelines were developed in just 3 months

### **Inclusive**

Over 1200+ organizations from 100+ countries registered to participate

#### Consensus

Consensus-based International Workshop Agreement (IWA) process in the international standards system



# What do the Net Zero Guidelines say?

The Guidelines provide guidance and recommendations on each stage of a net zero strategy, from preparation to reporting and impact, to help you navigate the existing landscape. They include:

- A definition of net zero and related terms
- Net zero guiding principles
- Guidance on how to contribute to global net zero
- Recommendations on governance, target setting, transparent communication, credible claims, and consistent reporting
- Directions to relevant prominent initiatives and standards that provide further information, methodology and verification



# What do the Net Zero Guidelines say? Key topics

#### Fossil fuels

Transition away from dependence on fossil fuels and apply policies to phase out

### Scope 3 emissions

All Scope 3 emissions should be accounted for in interim and long-term targets

#### Use of offsets

Only removal-based offsets can be used in a net zero strategy

#### Greenhouse gases

All greenhouse gases should be accounted for in your net zero strategy, not just carbon dioxide

#### Residual emissions

Only the emissions remaining (5-10%) after deep emissions reductions are completed can be counterbalanced using offsets

# What do the Net Zero Guidelines say? Key topics

#### **Avoided emissions**

Avoided emissions cannot be counted towards your net zero target. Organizations should act as solution providers to others.

#### Fair share

Those with greater historical responsibility and resources should make a proportionately greater contribution and support others to take action.

## Nature and biodiversity

Mitigation actions should take into account the need to preserve or enhance ecosystems and biodiversity.

#### Net zero claims

To claim net zero, only residual emissions should remain, and these should be counterbalanced by removals.

## Reporting

Leadership should be directly accountable for monitoring and reporting processes. Reporting should be at least annual, include what offsets were used and disclose limitations of data.
